ADVERTISEMENT FOR M.PHIL AND Ph.D ADMISSION, 2023.

Applications are invited for admissions in M.Phil program in the Basic Medical Sciences Institute (BMSI) for the subjects of Anatomy, Clinical Pathology, Microbiology, Pathology, Pharmacology and Physiology. Applications are also invited for admission in Ph.D Microbiology and Pathology.

NOTE: - All degree programs are affiliated with the University of Karachi.

ELIGIBILITY FOR M.PHIL:

- 1. At least 16 years of studies (M.B.B.S., B.D.S., B.S (4 years)/M.Sc.) or equivalent.
- 2. One year House Job Certificates as recognized by PM&DC/PMC for M.B.B.S./B.D.S. degree holders.
- 3. Foreign graduates must produce equivalent certificate from PM&DC/PMC/UoK.
- 4. Valid PM&DC/PMC Registration.
- 5. Candidates seeking admission in Clinical based M.Phil (Pathology, Anatomy & Clinical Pathology) program must hold M.B.B.S. degree, while for all other M.Phil programs at least 16 years of studies are required.

<u>REQUIREMENTS:</u> Attested copies of the following documents/certificates should be attached, while submitting application forms.

- 1. Four recent passport size photographs.
- 2. Matriculation Certificate & Marks Sheet.
- 3. Intermediate Certificate & Marks Sheet.
- 4. Marks sheet of last degree/M.B.B.S. degree with Consolidated Marks Sheet.
- 5. House Job(s) certificates (if applicable).
- 6. Valid PM&DC/PMC Registration (if applicable).
- 7. Two years valid teaching experience certificate from the Principal/Registrar of the College/Institution/University.
- 8. Copies of Research Papers/Publications.
- 9. Domicile.
- 10. Valid Computerized National Identity Card.
- 11. Copy of paid voucher.

MERIT: Admission shall strictly be on merit basis.

The admission will be granted on the basis of Test and Interview by the Departmental Research Committee of the concerned department. Guideline for Interview marks are given in Annexure-I. All candidates will be required to appear in the Entrance Test 2023 conducted by Education & Training Section, JPMC. This is mandatory for all the candidates.

a) The test shall comprise of the following sections:

Section-I Subject knowledge 80%

Section-II English and Communication Skills 20%

b) Candidates will be required to score at least 50% marks in each section to be eligible for consideration for the interview.

Note: Qualifying the admission test is no guarantee for admission.

- All the students who qualify the test will be required to appear in person for an interview to be conducted by the respective Departmental Research Committee (DRC) to finalize the admission procedure.
- Two years teaching experience will be preferred in the relevant subject/field from a recognized Medical Institution/Medical College/University on the closing date to the submission of form.
- Further credit marks will only be awarded to candidates who have published research papers in PM&DC/PMC/HEC recognized journals.

Provisional Admission for M. Phil.

- 1. Applications for provisional admission will be considered on the basis of eligibility, merit, availability of seats and supervisors.
- 2. Final admission list will be prepared by the DRC according to the following formula:
 - i. The marks obtained in the prerequisite degree examination will be given 50% weightage.
 - ii. The marks secured in the Entrance Test 2023 will be given 30% weightage.
 - iii. The marks obtained in the interview will be given 20% weightage.

Distribution of interview marks are given in **Annexure-I.**

Duration of M.Phil (**Minimum 2 and Maximum 4 years**), from the date of provisional admission. No further extension will be possible.

M.Phil. (With Course and Research Work)

- 1. All selected candidates will be required to complete the required course work from respective departments within stipulated time frame.
- 2. Candidates are required to attend at least 75% classes of each course.
- 3. The student has to pass the course work with CGPA 3.0 or more.
- 4. A student who will be declared short of CGPR shall improve it in the next available single chance by appearing in two courses having less than 70 marks i.e. grade B-.
- 5. If the student fails to attain a CGPA of 3.00 or more even after improvement chances, after one year or overall within three years, he/she will be given only a Post Graduate

Diploma (PGD) instead of M.Phil degree. Minimum 2.5 CGPA is required for Post Graduate Diploma.

- 6. After passing the course work with CGPA 3.0 or more, the student will be required to apply through proper channel for confirmation of admission and approval of research proposal within one year.
- 7. The student will submit a research proposal according to approved format of the ASRB through proper channel along with a copy of the marks certificate issued by the Semester Examination Section.

ELIGIBILITY FOR Ph.D:

- 1. M. Phil in the relevant subject.
- 2. C.G.P.A. should be more than 3.0.
- 3. Fifty (50%) passing marks in entrance test.

MERIT:

- 1. Fifty (50%) percent passing marks in Entrance Test of relevant subject.
- 2. Post M.Phil experience in the relevant subject.
- 3. At least 2 research publications in PM&DC/PMC/HEC recognized journals.
- 4. Interview before the Departmental Research Committee (D.R.C.).

Distribution of interview marks are given in Annexure-II.

Duration of Ph.D (3 to 8 years) from the date of provisional admission.

REQUIREMENTS: Attested copies of the following documents/certificates should be attached, while submitting application forms.

- 8. M.Phil degree & Marks Sheet.
- 9. Copies of Research Papers/Publications.
- 10. Domicile.
- 11. Valid Computerized National Identity Card.
- 12. Copy of paid voucher.

NOTE: Qualifying the admission test is no guarantee for admission.

SCHEDULE OF ADMISSION: Application Forms will be available from the Accounts Office of J.P.M.C. on the payment of Rs.5,000/- for (admission form including entrance test fee). Candidates have to submit completed forms along with their required documents duly attested by a Gazetted Government Officer (Grade-17 or above). Candidates who are Government Servants in Medical Colleges/other Institutions/Universities should apply through proper channel, while submitting advance copy of the application, that must reach us through the Executive Director's Office, JPMC, (for information only). The Provisional Offer letter will be issued only to the first

five candidates who are on merit list in respective subjects. Admission is liable for cancellation, if fee not deposited on time. Then the admission shall be offered to the next awaiting candidate on merit list.

- 1. Forms will be issued from Accounts Office, JPMC, Karachi after appearance of advertisement in the press on Sunday 07-05-2023.
- 2. Last date for submission of Application Form is **31-05-2023** and to be submitted in R & I Section at Administration Block of JPMC between 09:00 am to 02:00 pm.
- 3. Initial scrutiny of documents will be done by the respective Departmental Research Committee (D.R.C.) before submission of admission form in the Education & Training Section.
- 4. Admit Card will be issued from the Education & Training Section on 14-06-2023.
- 5. Entrance Test will be held on 17-06-2023.
- 6. Result will be announced on 22-06-2023.
- 7. Screened candidates will be called for interviews on **04-07-2023**.
- 8. Payment of first year fee has to be made at the time of joining.
- 9. The course will commence from 17-07-2023.

<u>NOTE:</u> Submission of false certificate is liable for his/her disqualification. The selected candidate must submit an Affidavit mentioning that he/she will not be involved in any political activity. Candidates who wish to cancel their admission can do so within 15 days of their joining, however fee is non-refundable.
